### AFRL – Enterprise Business System (EBS) Modernization

SingTone supported the migration of AFRL's Enterprise Business Systems to the cloud, including creation of ~300 hardened cloud servers and transfer of over 100TB of data. Services included configuration management, risk mitigation, user access controls, and contingency planning. The team ensured secure cross-domain interoperability with SIPRNet, DREN, and NIPRNet, while maintaining seamless business continuity during the dual-operation period. SingTone enabled full system integration and modernization for future scalability.



### AFLCMC – Contractor Supported Weapon Systems Data Exchange (CSWS DE)

SingTone provided project management, software development, and system engineering services to sustain and evolve CSWS DE. The team managed the full SDLC, Oracle-based backend, and IBM WebSphere middleware integration, ensuring continuity of operations. We performed risk mitigation planning, regression testing, patching, and interface testing across multiple environments. The project enhanced weapon system data flow and strengthened secure network interconnectivity.



### AFLCMC – Network Operations II (NetOps II)

SingTone delivered enterprise IT services including Help Desk, cybersecurity compliance, software and hardware accountability, and asset tracking at Wright-Patterson AFB. Responsibilities included VTC facilitation, AFNET user provisioning, and ticket-based resolution. The team managed over 10 hours of daily support and responded to critical tickets within one hour. SingTone ensured cybersecurity enforcement per AFI 17-130 and maintained compliance documentation and software licensing integrity.



### City of Dayton – American Rescue Plan Act (ARPA) Grant Processing

SingTone streamlined the City of Dayton's ARPA grant review workflow by developing custom scripts, automating calculations, and creating applicant-facing dashboards. The team customized COTS tools and developed a secure, user-friendly submission process.
